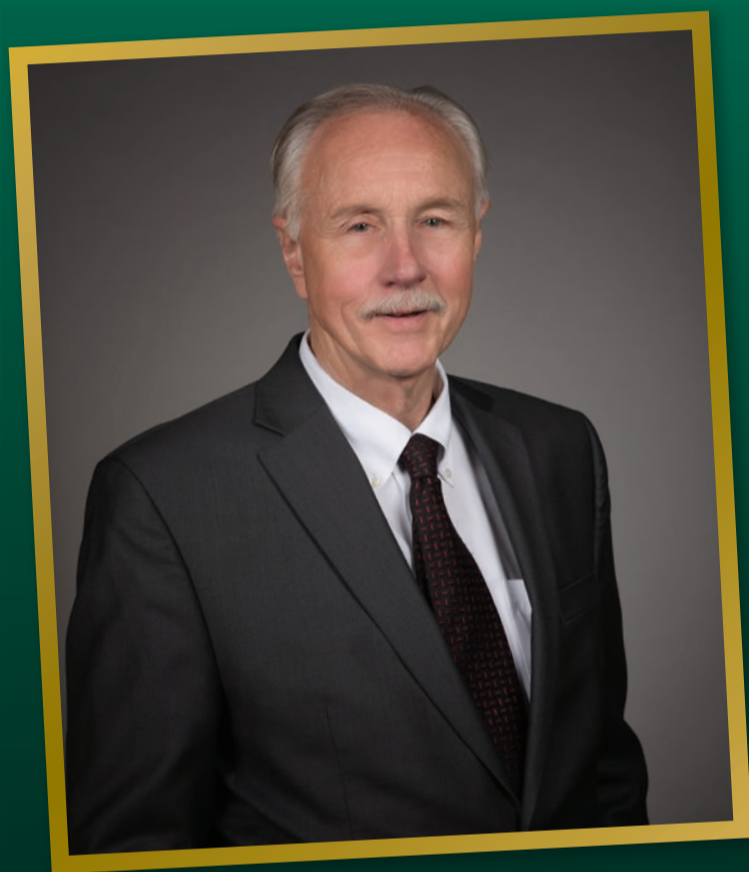
Dear Friend,
